 - c. projected 2019 year end total available = \$30,000 projected 2020 normal expenses = \$6,100 fee not added to 2019 taxes
 - fee added to taxes yearly (\$50.00 per tax unit) until projected fund amount is at least \$20,000, when fee no longer added to taxes
 - fee restarted when projected fund amount is below \$15,000
